1. Definitions:

"IRISS" means the software and system implanted by the University of Calgary known as the Institutional Research Information Services Solution.

"<u>User Guides</u>" means the documentation that describes the specifications of IRISS including its general use, functions, capabilities and operation.

2. Access, Responsibilities and Restrictions:

You will be permitted to access and use IRISS on a non-exclusive, non-transferable basis, subject to these terms and conditions.

You shall:

- a) be solely responsible for the accuracy, quality, integrity and legality of your data and the means by which you acquired your data;
- b) use reasonable efforts to prevent unauthorized access to or use of IRISS by others;
- c) only use IRISS in the manner for which it is intended and in accordance with the User Guides and applicable laws and government regulations;
- d) implement and follow reasonable security measures, both physical and technological to prevent unauthorized access to IRISS and any data stored therein; and
- e) implement and follow reasonable security measures to protect your data, including keeping assigned usernames and passwords confidential.

- g) copy any features, functions or graphics of IRISS.
