HIA-designated Health Research Ethics Board of Alberta consists of three committees [the Cancer Committee (CC), Clinical Trials Committee (CTC), and Community Health Committee (CHC)] operating as one Research Ethics Board. As such, members from one committee may attend another committee's meeting when their expertise is required. This ensures that members in attendance have the specific expertise, relevant competence, and knowledge necessary to provide an adequate research ethics review of the proposals under consideration. Additionally, to maintain continuity in committee activities, one committee chair or vice chair may be invited to chair or co-chair another committees' meeting as needed.

The majority of the members are Canadian citizens or permanent residents under the Immigration and Refugee Protection Act. HREBA is constituted and operates in accordance with the Alberta Health Information Act (HIA), the Tri-Council Policy Statement: Ethical Conduct for Research Involving Humans (TCPS 2), Good Clinical Practice (GCP) Guidelines of the International Conference on Harmonization (ICH), Health Canada's Food and Drug Regulations (FDR), Part C, Division 5 and is registered with the U.S. Department of Health and Human Services (HHS), Office for Human Research Protections (OHRP) where required.

Members named as Principal Investigators or Co-investigators on a study that is under review do not participate in discussions related to, nor vote on, such studies when they are presented; this applies to initial and continuing reviews.
